JCI's strategy includes a petition campaign, which has already gained significant global support, and a push for governmental proclamations to secure formal recognition of the initiative at both national and international levels. The ultimate goal is to present a resolution to the United Nations General Assembly (UNGA) to officially recognize July 10 as International Human Duties Day.

By advancing this initiative, JCI aims to inspire global responsibility, ethical leadership, and civic engagement, ensuring that human duties become an integral part of policymaking, education, and societal progress. ### Initiative background

- **4.**Pursue Prosperity: Support economic growth by preserving the freedom to pursue enterprise and adding value to the economy and society through volunteer work and other initiatives.
- **5.**Respect Human Personality: Cherish diverse opinions, preserve cultural heritage, and promote equity and inclusion for all individuals.
- **6.**Educate Yourself, Teach Others: Ensure access to education for all, support talent development, and use knowledge to uplift others.
- **7.**Lead Responsibly: Exercise freedom of expression responsibly, protect the interests of both majorities and minorities, create an environment of mutual respect, and promote and respect human rights.

The declaration emphasizes that achieving global peace, prosperity, and sustainability is a collective responsibility that requires individual efforts and mutual understanding. By adhering to these principles, leaders can create a positive impact on society and future generations.

# **2025 Direction**

Junior Chamber International (JCI) has a strategic plan to raise awareness of the initiative, promote the signature campaign to reach 100,000 signatures and gather proclamations from countries through their national organizations to support the Universal Declaration of Human Duties for Leaders and the establishment of International Human Duties Day on July 10.

### 1. Proclamations

### **Difference Between a Citation and a Proclamation**

- **Citation:** A citation is a formal public statement issued by an organization or authority to recognize an individual or group for their achievements or contributions. It is typically more personal and specific, highlighting accomplishments that benefit the community or align with the organization's values.
- **Proclamation:** A proclamation is an official declaration made by a government or authority to formally recognize an event, observance, or policy, often to raise awareness, encourage action, and mobilize public support.

### JCI's Use of Citations and Proclamations

Initially, Junior Chamber International (JCI) used citations to promote the Universal Declaration of Human Duties and the International Human Duties Day. This approach involved recognizing individuals and organizations that exemplified the principles outlined in the declaration, inspiring others to adopt and promote these values.

### **Strategic Shift to Proclamations**

In 2025, JCI is shifting its approach from citations to proclamations, focusing on securing official governmental recognition of July 10th as International Human Duties Day. This move is part of a broader advocacy strategy to institutionalize the celebration of human responsibilities and duties worldwide and ensure global recognition of the Universal Declaration of Human Duties.

By obtaining official proclamations from national and local governments, JCI seeks to:

- Establish July 10th as an official global observance dedicated to recognizing and promoting our shared responsibilities as individuals, communities, and nations.
- Gain political and public support for human duties, encouraging citizens and leaders alike to uphold and integrate these principles into daily life.
- Build momentum for formal UN recognition, strengthening the case for the initiative's endorsement at the UN Human Rights Council (HRC) and the UN General Assembly (UNGA).



### **Impact of Using Proclamations**

The shift to proclamations enhances JCI's efforts by:

- Securing Official Recognition: Government-issued proclamations legitimize July 10th as International Human Duties Day, ensuring long-term institutional support.
- Raising Global Awareness: Proclamations amplify the message, engaging the public, media, and policymakers to promote the importance of human duties and shared responsibilities.
- Encouraging Collective Action: Recognizing International Human Duties Day encourages educational initiatives, civic engagement, and policy discussions on integrating human duties into society.
- Strengthening the UN Advocacy Strategy: By demonstrating widespread governmental and civil society backing, JCI reinforces the push for formal adoption of the Universal Declaration of Human Duties at the United Nations.

### 2. Global Signature Campaign

In addition to governmental proclamations, JCI is continuing the support of the International Human Duties Day (IHDD) Petition, a signature campaign aimed at demonstrating widespread public and institutional support for human duties and responsibilities.

The campaign seeks to:

- Promote the recognition and adoption of International Human Duties, encouraging individuals, businesses, and institutions to take an active role in fostering mutual respect, sustainable practices, economic growth, and social justice.
- Showcase a united global voice, proving that people worldwide support the values of responsibility, ethical leadership, and collective well-being.
- Achieve a goal of 100,000 signatures in 2025, creating a strong public mandate that reinforces advocacy efforts for the initiative's formal endorsement at the UNGA.

- Enhance brand awareness, strengthening JCI's presence worldwide.
- Create financial sustainability and long-term community impact, ensuring lasting benefits beyond short-term initiatives.

By recognizing outstanding projects, JCI aims to incentivize leadership that actively promotes sustainable and responsible development, reinforcing the principles of human duties worldwide.


Principle 3: Sustain for the Future SDG13: Climate Action SDG: 15 Life On Land

# **2025 Actionable Steps**

### **1.Proclamation Guidelines**

JCI will develop and distribute Proclamation Guidelines to national organizations, ensuring a structured and strategic approach to securing governmental proclamations. These guidelines will focus on aligning the proclamations with the broader goal of securing endorsement at the UNGA and HRC, making them a diplomatic tool for engagement. By following the guidelines, National Organizations will be equipped to position proclamations as a pathway for member states to engage with and potentially sponsor the resolution at the UN.

#### 2. JCI National Organization's Role

Each National Organization will take the lead in advocating for the proclamation within its respective country. This includes engaging with government officials, diplomats, and key decision-makers to ensure that the proclamation serves as a stepping stone for official support at the UNGA. By leveraging local political contexts and diplomatic channels, National Organizations will create momentum that strengthens the case for the Universal Declaration of Human Duties to be formally recognized at the international level.



#### 3. International Human Duties Awareness Campaign

To amplify global outreach, JCI, through the 2025 Global Collaboration Committee, will implement an International Human Duties Awareness Campaign. This initiative will leverage events, workshops, media engagement, and strategic partnerships to spread awareness of the Universal Declaration of Human Duties and the International Human Duties Day. The campaign will focus on educating policymakers, engaging thought leaders, and mobilizing communities to ensure widespread recognition of the initiative.

#### 4. Human Duties Day Signature Campaign

JCI has set a goal to collect 100,000 signatures in 2025 to demonstrate global public support for the formal recognition of July 10th as International Human Duties Day. The campaign will be driven through online petitions, social media engagement, and grassroots mobilization, with a strong focus on engaging youth, civil society organizations, and corporate partners. The signatures will serve as additional leverage in diplomatic discussions, reinforcing the global demand for UNGA approval of the resolution.

#### 5. United Nations General Assembly (UNGA) Advocacy

The primary goal remains the presentation and approval of the resolution at the UNGA. The proclamations and signature campaign will be essential advocacy tools in securing government sponsorship and demonstrating widespread support. JCl will work closely with UN representatives, national delegations, and diplomatic allies to ensure the initiative gains the necessary momentum for formal adoption. Engagements will be tailored to emphasize how recognizing human duties as a global principle contributes to responsible governance, sustainable development, and social justice.

#### 6. Resolution Roadmap: HRC & UNGA Process

JCI will coordinate efforts to ensure the Human Rights Council (HRC) process serves as a foundation for the UNGA resolution. This will involve strategic engagement with UN missions, legal experts, and policymakers to refine the proposal and garner high-level support. National Organizations will play a role in engaging their country's UN representatives to advocate for early sponsorship and backing before the formal presentation at the UNGA.

#### 7. IHD Awards: Recognizing Leadership in Human Duties

The Best Human Duties Project Award will recognize JCI Local Organizations that implement high-impact projects aligned with the Universal Declaration of Human Duties. The award will prioritize projects that:

- Promote global responsibility, ethical leadership, and collaboration over charity.
- Tackle pressing global challenges with sustainable, long-term solutions.
- Enhance JCI's brand awareness and contribute to membership growth.
- Generate measurable community impact and financial sustainability.

By recognizing and celebrating best practices, the award aims to motivate JCI members and partners to actively contribute to the global movement for human duties, reinforcing the initiative's visibility and credibility at the UN and national levels.
